- **1. Approval of minutes**: Minutes of July 15, 2009, moved and approved, unanimously.
- **2. Update on the 2009 OS&R Plan**: Jennifer has received estimates from Zip Type, Minute Man and Staples and has taken the plan to the printer (Minute Man). We will be printing double sided. CD's will be provided to many of the boards. The State has given approval of our edits, but a formal letter has not yet been received.
- **3.ECTA Update**: Felicity and Deb Hamilton are now on the Board of ECTA. There is a new Executive Director Alex Van Alen. They are doing some mapping of public West Newbury trails and will be publicizing them with descriptions on their website. We agreed to share trail descriptions and will request to use their produced maps for our website. We will attempt to coordinate with them rather than duplicate efforts. The quote to improve the River Bend Road Trail was \$9000. (culvert repair, repair of muddy areas, repair footings near the bridge). Gary Bill reports that his department may be able to do some of this work in conjunction with a future Riverbend parking area project. Amy Bresky has offered to pay for some signage at Riverbend using the original Riverbend logo, and she will install.

Other updates: Con Com has approved the Riverbend Management Plan. Tracy Blais has formulated a warrant article for approximately \$35,000 for a parking lot for four cars and improvements to the access road to Riverbend for the October Fall Town Meeting.

4. Implementing OSRP Objectives in FY 2010 Discussion of next years goals and subcommittee composition was lead by Chair Barry LaCroix. What follows is an outline of the detailed discussion:

Goal 1 Recommend appropriate acquisition that facilitate open space and recreation goals.
