B. Seale called meeting to order at 4:30pm.

## I. **BUSINESS:**

Mello stated that Newburyport and Amesbury for recycling only. Board granted permission to J. Mello to use the Pipestave Recycling area as a staging area when preparing for cart delivery. J. Mello requested an excel spreadsheet of the multi-family addresses. Also, suggested was a letter to be sent to realtors in town reminding them that all town issued carts belong to the Town and are assigned to the address. It is the responsibility of the homeowner to leave carts behind when their house sells.

  - Waste Contract: J. Mello has agreed to honor the proposed contract for the fiscal years FY22-FY25 with regards to the automated cart program. J. Mello will provide the cost for convention curbside collection for FY22 so the Board will be able to discuss.
- Covid-19 update 5:15 pm Mosher-complaint.
  - Charles and Beth Mosher stated that they had listened to the last Board of Health meeting on October 20, 2020 in regards to the Youth Sports League flag football appointment where a discussion and vote occurred on <u>Youth and Adult</u> <u>Facial Covering Order</u>. Charles Mosher was curious why the Board of Health became stricter with implementing local regulations mid-way through the flag football season. Beth Mosher was also curious to know whether the Health Agent informed all parents of the newly adopted regulations. T. Fahey explained that it is the duty of the Health Agent and the Board of Health to protect the health and well-being of West Newbury residents. One way to do that is to impose stricter regulations than what the state of Massachusetts has implemented.in order to provide additional safety to the greater population and the children participating in a "close" contact sport.
