NK - Dispatch OT overspent by \$3,083.54, but Salary & Wages underspent by \$50,491.63, so just want to be clear, that means there will be a \$47,408.09 turnback?

NK - This, and two other transfers are coming from Highways, Sidewalks, and Trees account, which has \$57,213.34 balance, with the three transfers (\$1,689.53, \$764.97, and \$4,277.65 - totaling \$6,732.15), leaving a balance of \$50,481.19 to be turned back, correct? SF - Yes

NK - Why is this account not spent fully, when we have plenty of issues related to these areas? We have heard of complaints about street paving, there are certainly areas that could use sidewalks (Maple St., for instance), and the last couple years we have approved an article requesting additional funds to take care of tree pruning/removal. Since Mr. Jennings and Mr. Amaral have been in place, this department has done a better job of projecting and accounting its spending. However, this account should not be a fund to support the rest of the DPW accounts, and I am surprised it was not fully spent on the many issues we have related to these areas. If it is not going to be spent, this line item should be reduced in the future.

AJ - The money may not have been able to be spent just due to the time it takes from an administrative/procurement perspective. Unfortunately, Mr. Amaral is on vacation tonight, but when he gets back he can get us a complete answer on this question. But all the stuff you said is valid. This account will surely be fully spent in the future. We have many upcoming significant projects.
