Roberts stated that the reason for the transfers to salaries were increased work duties placed on the existing staff accommodating changes for the town manager. These transfers were approved 4-0. Investment committee: the towns investments seem to be doing well with a 4% return which is above the market average for the reporting interval.

Roberts had a conversation with Joe Anderson about the role of FinCom with the addition of a Town Manager. As far as Selectman Anderson understands, the roles of the finance committee will not change.
