1. Public Hearing - Planning Board's Recommendations for Changes - Town of West Newbury Planning Board Stormwater Management Regulations

The West Newbury Planning Board will hold a Public Hearing on Tuesday, May 16th, 2023 during a meeting that begins at 7:00 p.m. to consider the Board's recommendations for changes to the Town of West Newbury Planning Board Stormwater Management Regulations. The Planning Board's recommendations include but are not limited to 1) establishing a two-tier permitting framework that allows for a simpler permit application and performance standards for most single and two-family home projects outside the MS4 Regulated area, 2) requiring all projects disturbing one or more acres of land to apply for a Stormwater Management Permit, 3) removing design standards that are redundant with MA Stormwater Handbook or establish too high a standard, 4) adding detailed standards for construction-site stormwater management, 5) removing annual reporting requirements for most single and two-family home projects and 6) changing permit application fees.
