3. Public Comment. Public comment is limited to residents who may discuss items on the current agenda. Time is limited to 2 minutes per resident. The Chairman may allow for more time depending on the size of the agenda or the level of participation.
4. Discuss and re-vote on Articles that had been previously considered from the Spring Town Meeting. The article numbers are as follows:
 - Article 2: To see if the Town will vote to transfer the sum of \$404,993 from the School Stabilization Fund to offset the property tax impact of a Prop. 2½ override and pay the Town share of debt service associated with the building of the new Middle/High School.
 - Article 3 (partial – FY21 operating budget section 26): Increase DPW Town Building Operating Expenses by \$9,980 to fund multi-year warrantee for Electric Vehicle charging stations.
 - Article 5: To see if the Town will transfer from available funds the sum of \$240,000 to purchase a new dump truck, with plow and spreader to replace a 2008 International dump truck with same or comparable equipment, and to dispose of the existing dump truck in accordance with Town policy for disposition of surplus property.
5. Establish schedule for review of new Articles for the Fall Special Town Meeting
