Robert Janes called meeting to order at 4:30pm and read the above statement.

I. **BUSINESS:**

- Reviewed minutes January 21, 2021. APPROVED 3-0-0
- Steele Landfill was tested last week. Trench appears to be working. Report is forthcoming, and Health Agent will forward to Board.
- Discussed next meeting and Board decided to convene on February 17 to discuss the MIIA sports proposal from the Pentucket High School. Seale suggested getting back to the usual second and forth Tuesday of the month for BOH meetings, which would be March 9 and March 23, 2021.

After much discussion, R Janes made a motion to deny due to fairness and consistency. B. Seale seconded, unanimously in favor to **deny** request.

- Discussed automated barrel program. Krafton reported that G. Mello is in process of obtaining quotes on carts. Board questions whether we need a By-law and/or regulation on the books before implementing the program on July 1, 2021. Krafton will check with Town Counsel. Also, need to schedule a Public Hearing for the residents to attend. It's possible to do with Zoom, and have J. Mello available for questions and answers. Krafton will check with Conservation to see how they are conducting Public Hearings.
- Discuss HHW Event. Board agreed to accept Newburyport's date of August 14, 2021. (Though Krafton will put in a request for an October date) B. Seale and P. Sevigny and Krafton are committed to participate in event, R. Janes and T. Fahey will look at their work schedule.
