#### Dear Whittier Community Officials:

I am pleased to present the recommended budget and accompanying informational documents for Whittier Regional Vocational Technical High School.

The Operating budget that was initially presented to the Executive Sub-Committee reflected a 6.98% increase over the FY20 budget. After Executive Sub-Committee, the figure was reduced to 6.50%, which is lower than the 7.57% increase in mandated Net School Spending.

As a result of the Student Opportunity Act, the district received an additional \$1,147,402 in Chapter 70 funds, which represents an 11.24 % increase over FY20. These funds will enable Whittier to hire additional teaching staff in the areas of English, Math, English Language Learners, World Language, Dental Assisting and Engineering/Electronics, while keeping total assessments to member districts at a modest average increase of 2.77%.

The total capital budget for FY21 is \$695,000 of which \$345,000 will be used to complete the final phase of the athletic field project. The remaining \$350,000 will be put towards the cost of a feasibility study for the building, which is nearly 50 years old. In December of 2019, Whittier's Statement of Interest, which outlined the need for a building renovation, was invited into the Massachusetts School Building Authority's Eligibility Period and completion of a feasibility study is one of the first steps in that process.

Whittier's FY21 budget as submitted will allow the district to continue to meet the needs of its students as we prepare them for the future. I would like to thank the School Committee for their guidance and support during this budget process. Additionally, I am grateful to the staff, department heads and administrative team for being fiscally responsible with their budget requests.

Dear Whittier Community Officials:

I am pleased to present the recommended budget and accompanying informational documents for Whittier Regional Vocational Technical High School.

The FY22 Operating budget that was initially presented to the Executive Sub-Committee reflected a 4.61% increase over the FY21 budget. After Executive Sub-Committee, the figure was reduced to 2.42%, which is lower than the 4.49% increase in mandated Net School Spending.

The past year has been a most challenging one for school districts. Due to the hard work of our teachers, maintenance staff, support staff, bus drivers, cafeteria staff, and administrators, we have been able to provide a safe environment that has allowed us to offer daily in- person instruction for all student cohorts. The FY22 budget was prepared with the assumption that Whittier will be back to full in-person learning in FY22, and as such, reflects the reinstatement of many positions that were eliminated due to the state's reduction in our FY21 Chapter 70 funding. The addition of the ESSER II grant funds will allow us the flexibility to plan for scenarios other than full in-person learning without the need to reduce the proposed FY22 budget.

The total capital budget for FY22 is \$695,000 of which \$295,000 will be used to do some exterior repairs to our aged walkways and stairways. The remaining \$400,000 will be put towards the cost of the MSBA project as Whittier anticipates moving forward to the Feasibility phase.

Whittier's FY22 budget as submitted will allow the district to continue to meet the needs of its students as we prepare them for the future. I would like to thank the School Committee for their guidance and support during this budget process. Additionally, I am grateful to the staff, department heads and administrative team for being fiscally responsible with their budget requests.

Dear Whittier Community Officials:

I am pleased to present the recommended budget and accompanying informational documents for Whittier Regional Vocational Technical High School.

The District Budget presented to the Executive Sub-Committee reflects a 6.74% increase over the FY22 budget, which is lower than the 8.51% increase in mandated Net School Spending. Total assessments to member communities have increased by \$633,064, which represents a 4.16% increase over FY22

The Student Opportunity Act has provided the district with an additional \$1,233,777 in Chapter 70 funding for FY23, which represents an 11.15 % increase over FY22. Much of this additional funding is being targeted towards providing additional resources that will support the social and emotional health of our students as well as mitigate learning losses that have occurred due to COVID-19. Whittier's allocation of ESSER III grant funds will allow us to continue with our cleaning and safety protocols and expand intervention activities for students in their academic and/or vocational areas.

The total capital budget for FY23 of \$695,000, most of which will be applied towards the District's building project with MSBA, remains unchanged from FY22.

Whittier's FY23 budget as submitted will allow the district to continue to meet the needs of its students as we prepare them for the future. I would like to thank the School Committee for their guidance and support during this budget process. Additionally, I am grateful to the staff, department heads and administrative team for being fiscally responsible with their budget requests.

#### Dear Whittier Community Officials:

We are pleased to present the recommended budget and accompanying informational documents for Whittier Regional Vocational Technical High School.

The District Budget reflects a 4.80% increase over the FY23 budget, which is lower than the 6.31% increase in mandated Net School Spending. Total assessments to member communities have increased by \$306,453 which represents a 1.94% increase over FY23.

The District received an additional \$1,085,990 in Chapter 70 funding for FY24, which represents an 8.83% increase over FY23. This additional funding is being targeted towards providing resources that will continue to support the social and emotional health of our students as well as mitigate learning losses.

The total capital budget for FY24 remains unchanged at \$695,000; \$258,400 of which will be used to upgrade the building's technology infrastructure. The remaining \$436,600 will be applied towards the District's building project with MSBA, which continues to remain on schedule.









































# How Was The Decision Made? Why?

#### How was the decision made to build a new school?

- MSBA required Whittier Tech to explore various building options throughout the MSBA Feasibility Module including:
  - Code Upgrade
  - Renovation/Addition
  - New Building

Through a comprehensive qualitative and quantitative analysis of multiple options, the Building Committee determined that constructing a **new facility would be the optimal and most cost-effective solution.**

# Why was a new building chosen as the preferred option by the School Building Committee?

It was clear that a new facility would be the most cost effective solution.

- MSBA provides reimbursement for a new school.
  - A new building will allow the district to meet the vocational/technical needs of our CTE programs.
  - It will take approximate 3 years to complete with minimum impact on student learning.
- The significant code upgraded needed and required by law would be more expensive and there would NOT be any reimbursement by the state.
  - A code upgrade would not change the overall layout of the building
  - A code upgrade would take approximately 10 years to complete, have a large impact on student learning, and a large potential increase in costs.







#### Good afternoon everyone:

I hope you are all doing well! I wanted to update you on the status of our FY22 budget as well as our MSBA project.

On Wed March 10 the SC approved Whittier's FY22 budget. While the final approval will not happen until April 14 after the Public Hearing, it is unlikely that there will be any changes.

#### The total increase to our budget was 2.42%

Attached please find the FY22 assessment sheet, which shows the breakdown by community.

I also wanted to let each of you know that on February 10, the School Committee approved an appropriation of \$1,800,000 into the District's Capital Projects fund to cover the cost of the MSBA feasibility study. We have submitted all of the required eligibility phase paperwork and it is expected that we will be approved to move to the feasibility phase very soon.

#### Whittier did not need to borrow funds to cover this cost, nor did we need to request additional funds from our member communities.

Instead, we transferred \$1,105,000 from the District's Stabilization account and \$695,000 from the District's FY21 Capital Outlay account. We were able to utilize all of the \$695,000 FY21 Capital Outlay account for this purpose since the cost of phase 3 of our athletic field project (the track), was much lower than anticipated and was able to instead be covered through savings in our athletics operating budget. I have attached an excerpt from the February SC minutes (that were approved this past Wednesday evening) which details the SC votes taken to fund the study.

The Superintendent and I are fully aware of the many financial (and other) challenges that our member communities are facing during these unusual times and we greatly appreciate all of the support you have given to Whittier over the years








#### Alumni Spotlight Jason Giampa

I was born and raised in Haverhill. I played football and baseball at the Tech all four years. Currently I live in Tewksbury and am married to my awesome wife Michelle for 13 years. We have 3 kids ages 26, 11 and 9. These days you will find me coaching my kids or cheering them on at various sports.

When I was a kid, I was always interested in drawing and Architecture, and I knew the Tech had drafting so it was an easy decision. As a freshman my favorite class was drafting with Mr. Kelly. I also took Machine Shop, Auto Repair and Carpentry during my freshman year. With drafting as my major, I was able to participate in a co-op working in Methuen at Yankee Engineering as a Rod man and Draftsman. It was in this position that I first learned civil engineering and how to be a surveyor out in the field.

After graduation I continued to work at Yankee Engineering doing civil drawings and land surveying. A few years later, I was hired at the town of Methuen in the engineering department where I learned drainage and sewer calcs and drafting on sepia and mylar. I then started my construction career at William Berry drawing as-builts and site logistics. As part of the Suffolk acquisition of Berry, I began working on national, high-profile projects including the Encore Casino, Parcel 12, The Waldorf Astoria in NYC and the World Trade Center in Boston. For continuing education, I took night classes at the Tech in AutoCAD.

I learned the basics of how to use a pencil, line weights and free hand lettering. The Tech provided me with all the drafting table skills I needed to successfully pursue jobs with Yankee Engineering and the Town of Methuen. At Suffolk, my team plays a critical role in planning the construction process virtually from start to finish by laying out fence lines and equipment locations before any boots touch the ground, ensuring that jobs can move as safely and efficiently as possible. My vocational education background provided a strong foundation for me to grow into this career, continue my learning, and fuel my passion for construction logistics.

Job sites have almost every trade, AutoCAD, drafting, plumbing, HVAC, electrical, carpentry and masonry. The Tech can provide a head start on these in demand jobs. With an aging construction workforce and ongoing labor shortage, the industry is now more than ever in need of passionate, motivated and logistics-minded young professionals. Suffolk is continually investing in young minds through its Career Start rotational program, and vocational education is a fantastic springboard into this opportunity and others that set students and graduates on the path to success.

Do you believe vocational education is worth investing in? Absolutely! It provides the benefit of a 3-year head start in the industry. Companies like Suffolk are looking to the Tech for driven young professionals who will shape the future workforce of construction and other industries.

## The Future of Whittier Tech Updates Schematic Design for New Whittier Tech is Underway!

Superintendent Maureen Lynch and the Whittier Tech School Committee are delighted to announce that the Massachusetts School Building Authority (MSBA) has approved the preferred design for a new school building. The project is now well underway in the schematic design phase.

Since January 2022, the Building Committee has been convening to explore various building options, including code upgrades, renovation/addition, as well as new construction. Through a comprehensive qualitative and quantitative analysis of multiple options, it was determined that constructing a new facility would be the optimal and most cost-effective solution.

With the MSBA's approval of the preferred option, the design of the new Whittier Tech School will continue throughout the summer. Working closely with the MSBA, the next step involves a robust and detailed schematic design process that builds upon the approved preferred option.

The approved preferred option is a three-story, W-shaped building located on the current Whittier campus. The first two floors will house vocational, specialty, support, and community programs, while academic classes will be situated on the third floor. Additionally, the project will include the replacement of athletic fields displaced by the new facility, while the current stadium will remain unaffected.

Over the upcoming months, the schematic design, led by JCJ Architecture as the designer, will further refine and finalize various design aspects for pricing purposes. These include

educational programming, floor plan, massing, exterior facades, interiors, finishes, mechanical systems, technology, equipment, athletic fields, and site improvements.

The schematic design and estimation phase is scheduled to conclude in September 2023. Consigli was recently awarded the CM services for the Project and will be instrumental in preparing the estimate for the project in conjunction with the designer's estimator. At the completion of the estimate, JCJ Architecture and LeftField as the Owners Project Manager, will submit a **detailed schematic design package to the MSBA in October 2023**. The final state approval from the MSBA is expected in December 2023.

By November 2023, the project's final projected costs and reimbursement will be determined. The District plans to seek community approval of the proposed project during the winter/spring of 2023-2024. This process will involve several public forums, allowing the community to offer feedback and ask questions. Once all necessary approvals are obtained, construction is set to commence in spring 2025, with occupancy scheduled for September 2028.

Whittier Tech has collaborated with the MSBA since 2016 to develop a vision and explore options for a new school project. The existing facility, opened in 1973, currently serves 1,200+ students and offers education in 23 pathways within the fields of Arts and Communication, Construction, Manufacturing, Service, Technology, and Transportation. However, the current building faces numerous costly maintenance and structural challenges, as well as required code upgrades. It is no longer equipped to provide a 21st-century career technical education and adequately prepare students for success after graduation.

The MSBA partners with school districts and communities to support the design and construction of educationally appropriate, flexible, sustainable, and cost-effective public school facilities.

#### The District anticipates conducting a public forum in mid-September.

Dear Superintendent Lynch,

We greatly appreciated you joining us for a special Select Board meeting on November 13, 2023 to review the Whittier School Building Project. We as a board fully support the role of vocational programming in the education of the young people of West Newbury and throughout our region. Although we were asked to sign onto a letter of opposition to this project and the voting approach prepared by other members of Whitter's region, we decided to share our comments and suggestions in a separate letter. Our hope is that we can offer constructive feedback on the project and its path forward so that it will gain the support of all regional members and ultimately be successful.

At the outset, we want to say that we do not think renovation of the building is a wise or cost-efficient option. We agree that the only logical choice is to construct a new building with updated equipment and facilities that will last well into the future. The fact that the MSBA will only provide funding for a new building, thereby reducing the cost to region members, is evidence that renovation is not a desirable choice.

We therefore understand the decision to take advantage of the option for a majority rule regional vote. Given the relatively small proportion of students attending Whittier in many of the region towns, the project is unlikely to pass if individual town votes are taken. The consequence of this choice must also be understood, however. To communities that already feel that they have been blindsided by the cost of this project, having a regional vote makes it seem that their authority as a municipal entity is being undermined. In light of the public outery over the cost of this project, it also remains a distinct possibility

that even a regional vote may fail. That would force the option of rehabilitation, ending up costing taxpayers considerably more and resulting in an unsatisfactory facility for vocational programming. Given the urgency of a successful vote for this building project, it is imperative that a pause in the schedule as proposed occurs. We propose that a formal request be submitted to the MSBA asking for a delay on their vote in order to allow Whittier time to provide the proper outreach and consideration of regional member concerns. If they are willing and able to consider this, the following could be accomplished without the building project having to start over in the MSBA process:

- Allowing regional members to add these costs to their five-year capital plans and educate voters about long term costs
- The opportunity for clarification about alternative design and site options to reduce costs
- Establishment of regular communication updates to municipal officials and their residents
- Identification of potential additional sources of funding
- Review and revision of the Whittier Regional Agreement by members

If the request for such a pause was successful, we envision a kickoff meeting with municipal officials from all member towns and cities. A list of questions would be provided to Whittier ahead of time so that specific and thoughtful answers could be provided at this meeting. It would be important to consider and be responsive to these questions as an opportunity to educate the voters and move the project forward efficiently. Municipal officials and taxpayers seem to accept the need for a new school. They want to know what other designs were considered, why they were not chosen and what the cost impact of this was, though. We understand that the Building Committee and consultants have spent a lot of time evaluating the options. It's difficult for those being asked to pay for the project to just accept the final design without an understanding of what other options were considered, though.

Please let us know if there's a role we can play in supporting a proposal to the MSBA for pausing the project. Given that this has the potential to turn the significant opposition to this project around and build consensus among the 11 members of the region, it seems well worth the delay in final approval of the project.

Dear Selectboard Chair Reed,

Thank you for your recent invitation regarding the Whittier Tech Project to present in West Newbury. Unfortunately, I will be declining this invitation as Whittier Tech (WT) will be providing information and a WT tour on January 13, 2024 at Whittier Tech. As you know, since June 2022, when the designer was brought on board, the Whittier Tech Project has conducted an in-depth feasibility and schematic design phase, resulting in a proposed new school project. Prior to that, Whittier Tech informed all 11-district member communities of its pursuit of a capital project with the Massachusetts School Building Authority (MSBA) and, in February of 2016, established a stabilization fund to secure funding in anticipation of being invited into the MSBA program, which occurred in June of 2021. Since then, WT has held numerous public meetings on the Project, held four (4) public forums at WT, launched a project-specific website, launched a newsletter titled "Wildcat Wire," which provided an update to the Project, which was issued to member City/Town leadership, issued social media posts & press releases, and attended various district member City/Town select board meetings.

#### Other noteworthy project outreach specifics are:

- From January 2022 to December 2023, the WT School Building Committee held thirty-six (36) Building Committee Meetings and four (4) Community Forums. All meetings were publicly posted on the WT School website and the WT Project website, which was launched in July 2022.

- The WT project was identified to the 11-member districts yearly as part of the annual WT budget process.
- Annually, around the end of March to early April, WT invited municipal leaders from all eleven (11) member communities, including, but not limited to, Town Managers, Mayors, City Council Members, and Financial Managers, to review the annual WT budget and discuss upcoming projects including the WT building project.
- From September 2022 through November 2023, twenty-five (25) social media posts have been issued.
- From September 2022 through October 2023, sixteen (16) press releases have been issued.
- On November 18, 2022, WT invited municipal leaders from the eleven (11) member communities to attend a meeting at WT to discuss District approval options where the majority of municipal leadership favored a Districtwide vote. All Mayors and Town Managers were in attendance save for representatives of Merrimac and Rowley. It should be noted here that at this meeting, the anticipated district share for a new WT facility was \$296 million, these numbers were shared with all attendees. The final anticipated district share for the Project is now \$267.5 million, a reduction of \$28.5 million.
- In May of 2023, WT issued its first "Wildcat Wire," the official newsletter of Whittier Tech. This newsletter and subsequent Wildcat Wire newsletters have been sent to leadership in all eleven (11) member communities. The May 2023 Wildcat Wire introduced the newsletter and provided an update on community assistance WT provided to Groveland, an alumni spotlight, and a dedicated page on the Building Project. Since May 2023, seven (7) monthly Wildcat Wire newsletters have been issued.
- On August 9, 2023, WT hosted a Districtwide meeting with clerks from the eleven (11) member communities to update and discuss the Project and the District's intention to hold a Districtwide election. Weighing many factors at this meeting, the date of January 23, 2024, was established as the district wide election date, pending formal approval from the Whittier Tech Regional School Committee.

- On December 13, 2023, the MSBA held its Board Meeting, where the MSBA board unanimously approved the WT Project.
- On December 13, 2023, the Whittier Tech Regional School Committee held its meeting and approved the District Wide election/vote to occur on January 23, 2024.

#### INFORMATION TO BE INCLUDED

- The number of high school day students from West Newbury attending Whittier Tech for each year of the last ten years.
- Is West Newbury sending more high school day students or fewer to Whittier Tech over the last 5 years? How many more or fewer, on average?

- The latest 2023 data from Whittier show that West Newbury high school day students represent 1.1% of the total student enrollment (14 out of 1279). Why is West Newbury being asked to pay \$15.9M for this project based on our Pentucket enrollment and not a lesser figure more in line with our actual Whittier enrollment? (A figure more like \$2.88M which represents our 1.1% use of Whittier.)
- Are there other less expensive alternatives to meet the needs of the West Newbury students who attend Whittier? (For example, I heard that Newburyport has a pilot program with a Woburn-based trade school.)

#### PRINCIPAL'S REPORT

Mr. Chris Laganas, the Principal provided a principal's update. He stated it is exciting to have students back in the building for five (5) days. The students are settling in nicely to being back on Mondays for their vocational in-person day. On Monday, February 22nd students will still come to school following the same hybrid cohort but they will now have lunch at school and stay until 2:03 pm daily. All students are completing mid-term exams this week. Term 3 will begin after February vacation and Term 2 report cards will be out February 26th. Guidance counselors have started interviews with all of the middle schools remotely, in-person and through google meets throughout this week and during February vacation week. On Tuesdays and Thursdays, Kristine Morrison, Head of Guidance, is offering virtual information sessions. If you are interested, you can register online. Grab-and-go meals are still available at the end of the school day for students who wish to have meals available for their remote and weekend days. Remote Monday pickup sites for breakfast and lunch will continue to be available every Monday in February from 10 am until noon at the Poet's Inn entrance. Meals are provided for 7 days.

#### **BUSINESS MANAGER'S REPORT**

Ms. Kara Kosmes, the Business Manager stated that over the past 14 months, Whittier has been in the eligibility phase with MSBA for a school building project. She stated that this phase is coming to an end and she expects to move on to the next stage which is the feasibility stage. One of the requirements of this stage is for the School Committee to vote to authorize an appropriation to cover the cost of the feasibility study associated with the project. The first step is a vote of the School Committee to authorize the establishment of a Capital Projects Fund.

By motion of Mr. Irving, seconded by Dr. Testaverde to establish a Capital Projects Fund as outlined in the Business Manager's memorandum of February 4, 2021. Unanimously approved by roll call vote

Ms. Kosmes stated that in FY21, the School Committee approved a capital outlay budget totaling \$695,000. She stated that \$395,000 was allotted for the final phase of the athletic field project with the remaining \$350,000 to be applied towards the cost of the MSBA feasibility study. The field project is nearly complete and the cost is not expected to exceed \$250,000. Additionally, because of COVID-19, the athletics budget has unused funds which can be used to cover the cost of the track. This would free up the entire Capital Outlay budget to be available for the cost of the feasibility study.

By motion of Mr. Early, seconded by Mr. Irving to approve a transfer to reallocate the entire \$695,000 Capital Outlay budget appropriation for the MSBA feasibility study. Unanimously approved by roll call vote

Ms. Kosmes reported that the District has identified \$1,800,000 in funding that is available to cover the cost of the feasibility study. She requested that the School Committee vote to authorize a transfer from the Stabilization fund in the amount of \$1,105,000 and \$695,000 from the Capital Outlay fund into the Capital Projects Fund.

By motion of Mr. Early, seconded by Mr. LaBella to transfer \$1,105,000 from the Stabilization fund and \$695,000 from the Capital Outlay fund into the Capital Projects fund as presented. Unanimously approved by roll call vote

Ms. Kosmes stated that the final step of the process is for the School Committee to vote on the appropriation and authorization of \$1,800,000 from the Capital Projects fund to pay for the cost of the feasibility study.

By motion of Mr. LaBella, seconded by Mr. Fitzgerald to appropriate and authorize the amount of \$1,800,000 for the purpose of paying costs of the Feasibility Study for the Whittier Regional Vocational High School, 115 Amesbury Line Road, Haverhill, including all costs incidental and related thereto (the "Study") said amount to be expended under the direction of Whittier Regional Vocational High School Building Committee. To meet this appropriation, the District is authorized to expend said amount from the Capital Projects Fund under and pursuant to the District Agreement, as amended, or pursuant to any other enabling authority. The District acknowledges that the Massachusetts School Building Authority's ("MSBA's") grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the District incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the District. Unanimously approved by roll call vote

#### A. Request for Appointment of Matthew Dixon as Reserve Police Officer:

Police Chief Durand stated that Matthew lives in West Newbury, a recent graduate of the part-time academy, also from Merrimack College. (See Exhibit A, pages 6 for information) Also stated that he has a lot of availability, done well on his interviews on his testing, and would like to have him appointed as a reserve officer.

Matthew Dixon stated wants to thank everyone for the opportunity and stated he is very excited to serve his community and join the Police Department.

Motion made by Selectman Parker to appoint Matthew Dixon as a reserve police officer. Seconded by Chairman Archibald.

B. Presentation of Whittier Tech FY22 Budget and Potential School Building Project, Superintendent Maureen Lynch and Business Manager Kara Kosmes:

Chairman Archibald thanked Superintendent Lynch and Business Manager Kosmes for coming. Stated always enjoy hearing what's going on, it's very enlightening, and thank them for taking the time to do so.

Superintendent Lynch reviewed the finances and plans for FY22. (See Exhibit B, pages 7 through 11 for information) She stated that it's always good to have an understanding about this time last year and what were looking at as a budget, what happened throughout the months of

March and April and where we are now. Explained further in detail about the budget, current programs, and future plans.

Chairman Archibald inquired into the building project. Superintendent Lynch explained what the plan is and the feasibility study, referring everyone to the website to follow the building process, which will be posted soon. He also invited her to explain to the public how to apply for their school and what programs are offered and that they can also visit the website for information. She explained their programming offerings and advised everyone to contact her office if they would like to learn more about their programs. Chairman Archibald thanked them for their very informative presentation.

C. Special Event Permit Application: Horse Trials, Sunday July 11 and Sunday, October 10, and Adventure Trail Day, Sunday, September 12, West Newbury Riding & Driving Club:

Kathy Feehery explained this request. (See Exhibit C, pages 12 through 15 for information) Explained that the events on July 11<sup>th</sup> and October 10<sup>th</sup> are the usual Pipestave Hill events. Not sure what the number of participants will be this year due COVID requirements but hoping to run an event as in years past since it's a major fundraiser for their club and have been hosting this event for 35 years.

Town Manager Jennings inquired as to whether there was a discussion at the latest Parks & Rec meeting. Ms. Feehery stated that she didn't attend so she wasn't sure. Deb Hamilton stated that really needs to have exclusive ability to park horse trailers and to use the whole area for adventure trail, so sent letter requesting exclusive use of the area, which is only used exclusively the three times during the year, but club members do clean-up and trimming in the area, as well as donating funds to Essex County Trails Association, and has given at least \$1,000 per year for 15 years since running the event, and in return, ECTA has underwritten the Coffin Street Bridge, the Chase Street Bridge, did fill along the river, etc.

Chairman Archibald stated that the BOS had discussed with Park & Rec whether the issue of having two events at the same time on those weekends, and Park & Rec was under the impression that there were no issues and things could happen very well simultaneously. Deb Hamilton stated that they succeeded in putting things together the two years in a row but that they were anxious and stated that it's hard to predict with horses and that things are not always ideal.

Selectman Parker stated that he feels that somehow, we may have dodged a bullet and maybe that the event should be exclusive. Chairman Archibald stated that he agreed that it's not asking a lot, and they should be able to have the three days set aside for events, but feels that right now, it's in Park & Rec's hands until and if the BOS has to arbitrate. Town Manager Jennings stated that he's not sure of what came out of Thursday's Park & Rec meeting, but that the BOS could act on the special event permits in front of them but let that play out over the next couple of weeks with Park & Rec and if they didn't deal with it, see if can come to an agreement.

Motion made by Selectman Parker to approve the Horse Trials on July 11<sup>th</sup>, the Adventure Trail Day on September 12<sup>th</sup>, and the Horse Trials on October 10<sup>th</sup> at Pipestave Hill. Seconded by Chairman Archibald.

Jennings informed the Select Board the Safe Routes to School grant application had been submitted (see exhibit M for details). Jennings commended the DPW projects manager for assisting in helping make the submission deadline. No motion was made at this time.

### N. Update on recent meeting at Whittier Tech regarding proposed school building project with MSBA

Jennings and Parker reviewed a meeting they attended with superintendent Maureen Lynch and other town officials from the district (see exhibit N for details). Jennings stated the school would need approval from all 11 cities/towns in the district get through the MSBA process. Parker stated the construction option that would increase the student population was found to be too costly and therefore had been taken off the table. Jennings discussed areas of the school that would need to be upgraded to meet code compliance. No motion was made at this time.

## O. Update on Capital Improvement Committee process to review draft Capital Improvements Program

Jennings stated a draft of the Capital Improvements Program had been circulated. The CIC discussed the draft and will revisit the updates at the December 8<sup>th</sup> meeting. **No motion was made at this time.** 

#### P. Timeline and next steps to update Housing Production Plan

Jennings stated a meeting was scheduled for December 1, 2022 with the Town Planner, MVPC designee, and the Town Manager. Jennings stated the members of the Affordable Housing Trust were invited to attend and participate. No motion was made at this time.

#### Q. Timeline and next steps to update Hazard Mitigation Plan

Jennings stated the regional kickoff was scheduled for December 7<sup>th</sup>. Invitations to various town departments had been circulated. **No motion was made at this time.** 

#### R. Update on recent meeting with MIIA for annual review of insurance policies and coverages

Jennings discussed the annual MIIA review of insurance policies and coverage. Jennings stated that most likely cyber coverage would require two-factor authentication starting July 1, 2023. Jennings also informed the Select Board that municipalities renting out any portion of municipal building space would become increasingly more difficult as insurance coverage would not be issued. Jennings stated that West Newbury was grandfathered in but the town should continue monitoring this as it could change in the future. No motion was made at this time.

#### S. Follow up meeting assignment; placing items for future agendas

Archibald made a motion to adjourn to executive session in accordance with MGL Ch. 30A §21(a) 6: To consider the purchase, exchange, lease or value of real property if the chair declares that an open meeting may have a detrimental effect on the negotiating position of the public body (362 Main Street; 31 Dole Place); Parker seconded. Motion unanimously passed (3 Yes, 0 No, 0 Abstain). The Board adjourned to executive session at 10:30pm.

The Board returned to Open Session. Archibald made a motion to adjourn open session. Parker seconded. Open Session adjourned at 10:58pm.

#### **Regular Business:**

- A. Special Event Permit Application-Road Race on June 11 at 8am-Yukan Sports LLC (cont'd from 2/27) (See Exhibit A). Town Manager Jennings briefed the Board that the race organizers had already been moving through the appropriate channels to secure permissions, submitting a certificate of insurance, and arranging for a police detail, which Morrell went into greater depth on briefly. Archibald motioned to approve the permit. Reed seconded. The motion unanimously passed. (3 Yes, 0 No, 0 Abstain).
- B. Request for temporary signage Natale Smith, Pentucket Youth Football and Cheer (See Exhibit B). A representative from PYFC specified the locations of the temporary signs in accordance with Town Bylaws. Reed asked for the dates of the sign postings (March 15<sup>th</sup> to March 29th). Reed motioned to approve the signs. Parker seconded. The motion unanimously passed. (3 Yes, 0 No, 0 Abstain).
- C. Presentation of proposed FY24 Whittier Tech budget, and discussion of proposed MSBA construction project (for potential Town Meeting consideration in Spring 2024)

  The Superintendent and the Business Manager offered positive updates on the school including new program areas, scholars of distinction, as well as admissions statistics and grants received from the Commonwealth. Lynch stated that renovations of the school building would be no longer feasible, and that Whittier would need to seek state assistance in constructing a new building. Lynch stressed the hope that their process would be transparent as possible and offered information on costs of the new building (\$425,000,000). No motion was made at this time.
- D. Report on recommendations for FY24 Capital Articles Capital Improvements Committee (See Exhibit D). The Select Board discussed the Capital Improvement Committee recommendations on the Town Meeting Articles. Archibald queried Parker about the urgency of the sidewalk snowplow, which he replied was not fully effective in its role and a maintenance liability. The discussion also focused on concerns about not knowing the true costs of future projects in FY25 and beyond, given the increasing prices across many sectors. No motion was made at this time.
- E. Presentation of proposed FY24 Water budget Board of Water Commissioners (See Exhibit E). The Select Board heard data from the Water Commissioners, one of whom clarified figures written incorrectly in the Budget that would be amended. Reed was curious about potential line-item transfers, which would need to be approved by the Finance Committee, and Janes and Jennings clarified how the budgeting drafting was done- with specific respect to water agreements with Newburyport as well as impacts on how the Budget was structured because of COVID-19-era water usage changes. The Department of Revenue at the state level had found such structuring invalid, and it necessitated a greater Budget for FY 23-24 to compensate. Continued discussion of the budget from the Water Commission occurred, which focused on the difficulty in predicting future costs and expenditures, the thinly stretched workforce, and salaries. Reed had reservations about the vagueness of the salary line item, thus she will be abstaining from the vote pending a discussion from the Water Commissioners regarding the salary line item. Parker made a motion to approve the budget. Archibald seconded. The motion passed. (2 Yes, 0 No, Reed abstaining).
- F. Follow-up discussion of proposed warrant articles for spring Annual and Special Town

needed to be examined to improve efficiency, leaning toward a stronger Town Manager form of government. Reed said she felt that potentially hiring a management consultant might be a good idea to examine things like the Board's Agendas, workflows, and priorities. Wile stated that the relative stability of the Town's staff and finances meant that the number of projects that could be taken on increased, which had contributed to an over-burdening of the Manager and Board. The perpetual feeling of "putting things off" was rued by the three Select Board members. Jennings told the Board about a previous experience he had working with a management consultant during his tenure in Westford, MA. When this was received with a positive Board response, Jennings promised to look into the consultant. No motion was made at this time.

O. Discussion of designating Select Board liaisons to different Boards/ Commissions/

(See Exhibit P, p. 112-116). Reed motioned to approve the Minutes as amended for July 17, 2024.
Parker seconded. The motion unanimously passed. (3 Yes, 0 No, 0 Abstain). Reed motioned to approve the Minutes as amended. Parker seconded. The motion unanimously passed. (3 Yes, 0 No, 0 Abstain).

#### **Town Manager Updates**

- Q. Receipt of Route 113 base maps to solicit public input re corridor planning effort (See Exhibit Q, p. 117-120). Jennings said that drafts of base maps had been received by the Town. He further explained that the idea was to get good base maps with sidewalks and crosswalks on them for the benefit of the public during events/forums with minimal extraneous information. Closing out the update on this Item, Manager Jennings relayed that West Newbury had officially submitted paperwork to the Massachusetts Department of Transportation for 25% Design Permitting. No motion was made at this time.
- R. Update from recent check-in meetings with Gienapp Architects re Page School study (See Exhibit S, p. 121-137). Jennings provided details on the laudable, collaborative work between the Page School and Town staff, and the architecture firm. Jennings expressed the Town felt the firm was right on target in terms of the project's scope, and that an additional contract for work on sills/lintels was being floated to move things forward. September 19<sup>th</sup> had been selected as the date for a presentation from Gienapp Architects to the Select Board. No motion was made at this time.
- S. Recap of recent Town Clerks' meeting re anticipated Whittier Election (re MSBA project)

Sharing notes from the Assistant Clerk who had attended an initial meeting for election planning, Blatchford walked the Board through the special election for school building funding. A follow-up meeting was to take place on October 9th. The District would be reimbursing the municipality for expenses incurred running the election (but the total they could give each Town is not clear). Jennings stated he would investigate with the Whittier Technical High Business Office what the latest cost projections for the building would be, and how it would impact the Town. No motion was made at this time.

- T. Invasives Management contract MEPA filing and effect on schedule for contractor management of invasive species at Cherry Hill site
  (See Exhibit T, p. 138-211). As a result of bureaucratic holdups and the permitting process, the work on the invasive plants would not be fully underway until later in September. Jennings stated Greene had taken on much of the work in the process in addition to her regular duties. No motion was made at this time.
- U. Water consultant report re MBTA Communities planning initiative
   The Town Manager said one thing he hoped the Town would be getting its hands on soon was a model created by Tata and Howard based on their hydraulic study, and in turn this model would enable West Newbury to do its own modeling. Reed wanted clarification on whether the Town would actually be able to use said model or if Tata and Howard would run the model for the Town. No motion was made at this time.
- V. Updates on other ongoing/active projects/initiatives (See Exhibit V, p. 212-250). Jennings said the off-street parking that had been requested for conservation land (Artichoke Trail) off of 28 Middle Street had been rejected. Additionally, Jennings said the MVP Grant process was humming along, and the required















































# How Was The Decision Made? Why?

# How was the decision made to build a new school?

- MSBA required Whittier Tech to explore various building options throughout the MSBA Feasibility Module including:
  - Code Upgrade
  - Renovation/Addition
  - New Building

Through a comprehensive qualitative and quantitative analysis of multiple options, the Building Committee determined that constructing a new facility would be the optimal and most cost-effective solution.

# Why was a new building chosen as the preferred option by the School Building Committee?

It was clear that a new facility would be the most cost effective solution.

- MSBA provides reimbursement for a new school.
  - A new building will allow the district to meet the vocational/technical needs of our CTE programs.
  - It will take approximate 3 years to complete with minimum impact on student learning.
- The significant code upgraded needed and *required by law* would be more expensive and there would *NOT* be any reimbursement by the state.
  - A code upgrade would not change the overall layout of the building
  - A code upgrade would take approximately 10 years to complete, have a large impact on student learning, and a large potential increase in costs.


